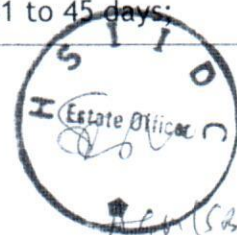

Scheme of HSIIDC for the allottees to clear Outstanding Dues of enhanced cost in one go

Scheme	Clearance of Outstanding Dues on account of Enhanced Compensation (CoEC)
Objective	In order to improve its client interface and to provide more comfort to the allottees, Haryana State Industrial & Infrastructure Development Corporation Limited (HSIIDC) introduces this scheme for relief in payment of interest and penal interest to those allottees who want to clear the entire outstanding of enhanced cost in one go. This move has been aimed at providing relief to the entrepreneurs.
Effective date and period	The scheme will be effective from 1 st Feb, 2018 and will close on 17 th March 2018.
Relief under the scheme	<p>a) In respect of those allottees who are desirous of clearing the entire outstanding amount on account of enhanced cost in one go, the interest on the outstanding amount chargeable from them will be frozen as on 31.07.2017.</p> <p>b) The following benefit on penal interest (2% or 3% as the case may be) to such allottees will also be given:-</p> <ul style="list-style-type: none"> i) 100% waiver, if the entire outstanding amount is cleared in one go within 15 days; ii) 75% waiver, if the entire outstanding amount is cleared in one go within 16 to 30 days; iii) 50% waiver, if the entire outstanding amount is cleared in one go within 31 to 45 days;

	<p>c) The above offer for clearance of outstanding as stated above at (a) and (b), will be open only for those allottees who opt to clear the entire outstanding amount in one go within the respective number of days from the date of issue of public notice to this effect.</p> <p>d) The decision of the Corporation in all matters in relation to this scheme would be final and would not be called in question at any stage by any allottee.</p> <p>e) Any amount paid in pursuance of the scheme not amounting to full payment finally determined to be payable under this scheme will not be refunded but will be adjusted against the amount outstanding from the allottees as per the normal procedure.</p>
Nodal Officer	<p>Scheme will be operated at the Corporate Office, Panchkula level.</p> <p>For smooth and effective implementation of scheme, the Corporation has appointed Mr. S.B.Kaushik, Assistant General Manager (Mobile No.09417785636) as nodal officer.
