1. The allotment rate of industrial plots in I.E. Tohana is Rs. 3000/- per sq. mtr. In case of any enhancement in future, the same shall have to be paid by the allottee. The allotment shall be governed by the provisions of EMP-2011.
2. The draw of lots for allotment of plot nos. shall be conducted on 17.7.2014 at 11.00 AM in the Conference Room of the Corporation at C-13 -14, Sector 6, Panchkula. The Regular Letters of Allotment (RLAs) containing detailed terms and conditions of allotment shall be conveyed to the selected applicants individually after draw of lots.

3. The allottee shall be required to implement the project after constructing building and installation of plant and machinery as per project report within a period of three years from the date of offer of possession. During this period, change in constitution of the allottee firm and induction of third party shall not be permissible.

5. The absentees, if any, shall be given another opportunity to appear before the Allotment Committee for considering their application for allotment out of left out plots
